## **CONTEST SETTLEMENT**

### **Introduction :**

An extension for the game “Mr. Jack” is planned to be published by Hurrigan for next Essen’s fair (2007).

For this occasion, a contest is organised by Hurrigan

### **Article 1 : Object**

Participants must make a proposal for a new character with an original special ability. Name of the character can be suggested. The winning character will be include in Mr. Jack’s extension.

### **Article 2 : Inscription et participation**

Participation to this contest is free, without obligation of purchase, opened to any individual, whatever their age or their country of origin, other than the Hurrigan’s staff, Mr. Jack’s Game designers and their family.

If under age people take part, this contest is done under the responsibility of the legal representative being able to justify parental authority. The participation is limited to only one participation per home (even name, even address).

Any fraud on these points involves the invalidation of the candidate.

### **Article 3 : Schedule**

Proposals have to be send from 2007 the 1<sup>st</sup> of April to 2007 the 30<sup>th</sup> of April, in french or english, at the following mail address : [mr.jack@swissgames.net](mailto:mr.jack@swissgames.net).

Only proposals received on this mail in english or french during this time will be examined.

#### **Article 4 : Jury – Winner**

Jury is composed of the two game designers of Mr. Jack, Bruno Cathala and Ludovic Maublanc. The winner will be choosed on following criterias:

- originality of character's special ability
- compatibility with the existing characters in the basic play
- compatibility with game's theme.

The name of the character will be choosed in collaboration with the game designers. In case that the winning character has been proposed by several participants, the winner will be the first contest participant to have proposed it. (The email date is taking in account)

#### **Important:**

In addition to the character that will be choosed at the end of this contest, three other characters have still been designed by the two game designers. (The extension will show four new characters.)

To guarantee the anteriority of these three characters, and to avoid quarrels on possible similarities, these characters have been deposed to [www.trictrac.net](http://www.trictrac.net) webmaster.

#### **Article 5 : Résultats**

Contest results will be announced 2007 the 6<sup>th</sup> of may, occasion to the swiss game designer meeting organized in " La Tour de Peilz (Swizerland) ".

#### **Article 6 : Prize**

The winning character will be published in the extension.

For character's face, the illustrator will caricature the winner.

Moreover, gaining it will receive three basic boxes and three extensions dedicated by the illustrator and the two game designers

#### **Article 7 : General Informations**

Participation to this contest implies acceptance by the candidates of all the clauses of this settlement. All difficulties as for the application of the settlement will be the subject of a sovereign interpretation of the organizers. Hurrican reserves the right to curtail, modify or cancel the contest if it estimates that the circumstances require it.

Because of acceptance of their prizes, the participants authorize Hurrican to use their name, first name, and their contribution, without reserve nor restriction. This will give them no particular right, remuneration or any other advantage. Particularly, character's publication won't lead to perception of royalties.

No correspondence will be exchanged concerning contest conditions, neither for the period of April 1 to April 30, 2007 nor later, between the organizers and the participants.
